Mr. Johal addressed the GVTA Police Board as a representative of the Civil Society Development Project, an organization formed to raise interest on public issues. The Civil Society Development Project is concerned with the manner in which the decision to arm the GVTA Police Service was made. The Society is of the opinion that there was no public consultation and the decision-making process lacked transparency. Mr. Johal asked that the decision be set aside and that a new process that includes public consultation be initiated.

Mr. Johal also expressed concern that the composition of the GVTA Police Board may compromise the oversight of the GVTA Police Service as there is no direct public representation. He suggested that the composition may create a perceived conflict of interest.
